### **3-4 year-old Funding**

The government provides Early Years Funding for children starting from the term after their 3rd birthday. This funding is designed to offer **15 or 30 hours per week of free, high-quality, flexible childcare during term time**. (Standard Offer - 15/30 hours term-time across 38 weeks, Stretched Offer - 11.18/22.35 hours across 51 weeks).

Please note that the funding **does not cover the cost of meals, consumables, or any additional hours** beyond the funded entitlement.

- **15 hours of funding** is available to all eligible 3–4-year-old children.
- To access the **additional 15 hours (totalling 30 hours)**, families must apply online to check eligibility. Generally, both parents must be working **at least 16 hours per week** and earn **below a certain income threshold**.

To access any funding entitlement, a **completed funding form** must be returned to the setting at the time of application or when the child becomes eligible.

3-year-old Funding	
A child Born in the period	Will be eligible for a free place
1st Apr - 31st Aug	1st Sept following child's 3rd birthday (Autumn Term)
1st Sept - 31st Dec	1st Jan following child's 3rd birthday (Autumn Term)
1st Jan - 31st Mar	1st Apr following child's 3rd birthday (Autumn Term)

### **2 years old Funding**

We also accept **funding for eligible two-year-olds**. To qualify, families must meet certain eligibility criteria to apply online visit here. <https://www.gov.uk/free-childcare-if-working/apply-for-free-childcare-if-youre-working> If eligible, you will receive an 11-digit eligibility code. You must confirm your code, national insurance number and child's date of birth so we can check that the code is valid.

These entitlements are offered **completely free**, and we **do not charge any "top-up" fees** to cover the difference between the government funding and our standard hourly rate. However, please note that **any additional hours beyond the funded entitlement**, as well as the cost of **meals, consumables, or extra activities**, will be charged separately.

Additional hours will be charged according to the following table:

There will also be a daily consumable charge billed according to the following table:
